- 7.1 The Queen's Platinum Jubilee Discussed were options of planting a tree, organising an afternoon tea at the Golf Club, and purchase of a teak bench.
  - The planting of a tree Winscales Parish Council is made up of Farming land, industrial land, a Golf Club, a Care Home and recently a School of special needs, all of which are privately owned. Within the hamlet of Winscales there is a small cluster of dwellings and the Hunday Manor Hotel, after this there are a scatter of dwellings. The parish council has no land, no Village Hall, no church, or a village green MT will ask if the Golf Club would site a tree.
  - Afternoon Tea Councillors said that this had been tried on several occasions with little success, how many to cater for – MT will ask for a quote from the Golf Club
  - A memorial bench HH suggested a bench with a plaque and siting it within the grounds of Hunday Manor Hotel, would parishioners be allowed entry to sit on the bench? AM to contact owner/manager of Hotel
